CALL TO ORDER

The meeting was called to order at 6:05 pm by Board Chair Erik Yager.

Chairman Erik Yager closed the meeting at 6:06 p.m., announcing that the matter before the Board was a personal matter and that in connection with this, the following was determined:

A motion was made by Trustee Alec Nisbet to rehire Superintendent DeBruycker with the following contract revisions:

- a) Rescind all past contracts

b) Issue a three year contract (2007, 2008, 2009) with all current benefits and the following changes:

1) reduce the number of contracted days from 207 to 202 per contract year

2) additional wording to include 12 university/graduate credits per contract year paid by the District #35, however, any credits failed or withdrawn have to be repaid to Gallatin Gateway School District

c) Salary of \$71,000

Trustee Jess Holloway seconded the motion. For Holloway, Nisbet, Robbins, Thiem, and Yager, Opposed: none. Motion passes unanimously
