The Gallatin Gateway School General Fund Levy **PASSED** by 63 votes.

The Bozeman High School General Fund Levy **PASSED** in the Gallatin Gateway School District by 41 votes.

The Board recognized that there were 1184 registered Gallatin Gateway School District voters, 257 voters cast ballots on Election Day and an approximate voter turnout of 22%.
