Call to Order

The Board of Trustees of the Gallatin Gateway School District #35 met at 1:30pm on Thursday, November 10, 2016 in the Gallatin Gateway School Board Room. Board Chair Donna Shockley presided and called the meeting to order at 1:34pm.

Presiding Trustee's Explanation of Procedures
