Board Chair Donna Shockley led a discussion and conferred with Steve Johnson regarding the potential growth, which may occur when the Gateway Village Subdivision begins to sell lots. Some key matters discussed included: 1) Land acquisition options (i.e. possibility of approaching developer to dedicate and donate park land to the School District); 2) Projecting population/school enrollment of development for entire project (i.e. 2.5 people per house and approx. 20% school aged children or approx. 44 elementary and 23 middle school students); 3) Funding options for anticipated enrollment increases; 4) Timeline of project could be up to 10 years for total build out; 5) Estimated Construction cost for schools (\$40,000/student); 6) Recommendation for hiring general contractors or OCR (owner's construction representative); 7) Obtaining community input on future of 1914 Building; and 8) Bonding Capacity and bond ratings.
